Welcome to Safer Internet Forum 2025



The Safer Internet Forum (SIF) is a key annual international conference in Europe where policymakers, researchers, law enforcement bodies, youth, parents and caregivers, teachers, NGOs, industry representatives, experts and other relevant actors come together to discuss the latest trends, opportunities, risks and solutions related to child online safety and making the internet a better place. The Forum will take place in a hybrid* format on Thursday, 4 December 2025, with a theme of Why age matters: Protecting and empowering youth in the digital age.

The 2025 Safer Internet Forum will discuss how to ensure age-appropriate online experiences through a proportionate and children's rights-centric approach. The discussion will include age assurance methods, as well as other complementary tools, to support parents in making responsible choices, with some focus on video games. The discussions will contribute to the priority of the European Commission, as expressed by President von der Leyen, to further strengthen the protection of minors online. SIF will bring together a variety of public and private stakeholders, including children and young people, to discuss the current state of play across and beyond the European Union, and look forward to future developments.

As in previous editions, SIF will enjoy a youth-led format: the event is organised with the support of a <u>Youth Advisory Group (YAG)</u>, which will work alongside EUN's BIK Coordination Team and the European Commission to prepare the SIF programme, and the role of children and young people in particular.

During the Forum, the sessions will be animated by the <u>BIK Youth Panel</u>, composed of young people from the national youth panels of <u>European Safer Internet Centres</u> and children from the <u>EU Children's Participation Platform</u>. Young people will express their views and share their positive experiences online, as well as their challenges, when using digital services with many other stakeholders, such as policymakers, industry, civil society, academics, parents and educators.

BIK Youth Panel 2025

Each year, a Better Internet for Kids (BIK) Youth Panel is organised prior to and during the Safer Internet Forum (SIF). Drawn from national youth panels convened by <u>Safer Internet Centres across Europe</u>, BIK Youth Panellists are encouraged to voice not only their personal opinions and challenges, but also those of their peers whom they represent at a European level. This year, youth from national Safer Internet Centres have been joined by five youth members of the <u>EU Children's Participation Platform</u>.

Since mid-September, through a series of online meetings, BIK Youth Panellists have been actively preparing their contributions to this year's Forum by sharing their respective perspectives on better and safer internet issues with their peers, agreeing on key themes, and preparing awareness materials on these topics.

In the days preceding this year's Forum, a group of 33 BIK Youth Panellists from 25 European countries have come together, face-to-face in Brussels, to finalise their work which they will present throughout the course of the day. Together with the SIF Youth Advisory Group, they will also lead various discussions to ensure that their voices can inform the perspectives of the various stakeholders participating in the Forum, and influence ongoing work in this field.

We take this opportunity to thank the members of the SIF Youth Advisory Group and the BIK Youth Panel for their dedication and commitment to creating a safer, better internet for their peers and young people across the globe.



Meet the other Forum speakers and contributors



Henna Virkkunen

Executive Vice-President for Tech Sovereignty, Security and Democracy, European Commission

As Executive Vice-President for Tech Sovereignty, Security and Democracy, Ms Henna Virkkunen is tasked with combating the increasingly complex security threats facing the EU, whilst at the same time strengthening our external borders and our internal security. This goes hand in hand with her responsibility to ensure our freedoms, justice and democracy are strengthened too. Furthermore, she is responsible for the Digital and Frontier Technologies portfolio. This entails leading Europe's efforts in shaping a competitive, resilient, and inclusive digital future and maintaining or attaining leadership in strategic digital technologies.

Prior to joining the European Commission Ms Virkkunen served as a Member of the European Parliament for over ten years. As a Member of the Committee on Industry, Research and Energy, her work focused on digitalisation and frontier technologies.

Ms Virkkunen has held various ministerial positions in Finland, namely Minister of Transport and Local Government (2014), Minister of Public Administration and Local Government (2011-2014) as well as Minister of Education (2008-2011).



Dirk Bosmans

Director, PEGI s.a. (Pan-European Game Information)

Dirk Bosmans is Director of PEGI s.a. (Pan-European Game Information), the organisation that runs the European age rating system for video games and apps. Based in Brussels, he oversees the continuous development of the PEGI system and works with national trade associations, government stakeholders and industry partners across Europe on raising awareness among parents about video game culture and media literacy in general, and age ratings for games in particular.



Dóra Dávid

Member of the European Parliament

Dóra Dávid has been a Member of the European Parliament since July 2024. She is a member of TISZA, the new democratic opposition party in Hungary. TISZA is part of the centre-right European People's Party, the largest political group in the European Parliament.

Dóra sits in the Parliament's Committee on Internal Market and Consumer Protection, where she focuses on EU digital policies, especially on the protection of minors online, Al policy, tech sovereignty, and simplification of legislation, among other issues.

Dóra is a multilingual, London- and Cambridge-educated, qualified lawyer with many years' experience advising multinational companies in competition, data protection, and consumer protection law. She has worked at international law firms, global tech companies, an international NGO and in an EU institution.

Amaia Echevarría

Director, Unión de Asociaciones Familiares (UNAF), Spain

Amaia Echevarría is the Director of the Unión de Asociaciones Familiares (UNAF), an organisation that has championed the rights and well-being of families in Spain for over 35 years. With more than 20 years' experience leading projects across the social and corporate sectors, Amaia has demonstrated a strong commitment to developing social policies and delivering public services that strengthen and support family wellbeing, diversity and gender equality. She holds a BSc in Business Administration, a BA in Business Studies, and an MSc in Marketing.

Her professional career spans both the private sector-where she has held senior management positions in prominent companies-and the social sector, where she has played a pivotal role in team leadership and the development of projects with significant social impact.

As a mother of two teenagers, Amaia also brings a personal perspective to the challenges families face in the digital age. Her extensive collaboration with families in educational settings has provided her with valuable insights into the practical realities of how families navigate the balance between ensuring youth safety online and supporting their development as confident, responsible digital citizens. Amaia also complements her professional work through active involvement in various associations, contributing her expertise as a member of Boards of Directors and bringing specialist knowledge on equality, social equity and family rights issues.



Elizabeth Gosme

Director, COFACE Families Europe

Elizabeth Gosme is a mother of two girls and the Director of COFACE Families Europe. COFACE is a network of 50+ family organisations across 23 countries advocating for the rights of all families without discrimination through various tools: advocacy and campaigning at the European Union level for strong social rights and gender-responsive family policies, building European research projects, developing practical tools to support parents, families, and children. Based on its digitalisation principles, 2030 Child Compass, and DigiGen research, COFACE works closely with the EU institutions, Better Internet for Kids, European Schoolnet, and key ICT industries to promote child rights and safety online. This is done through a whole-family lens, advocating for regulation, self-regulation, and education tools to empower children and their families in the digital environment





Niamh Hodnett

Online Safety Commissioner, Coimisiún na Meán, Ireland

Niamh Hodnett is the Online Safety Commissioner at Coimisiún na Meán, Ireland's media regulator. She oversees the organisation's Policy & Research Division, including responsibility for the development of the Online Safety Code. During 2025, she is the Vice-Chair of the Global Online Safety Regulators Network.

Niamh has extensive experience in designing, enforcing and managing compliance with regulatory obligations at both an Irish and EU level. Her expertise spans online safety, data protection, cybersecurity, competition, consumer protection, and communications regulation. Niamh has brought criminal prosecutions for regulatory breaches, as well as civil enforcement compliance proceedings. She has in-depth litigation experience of appeals and judicial reviews.

A qualified solicitor, Niamh has previously worked at ComReg, Ireland's communications regulator, at law firms in both Ireland and Brussels, and in a variety of in-house legal and regulatory roles. She has co-authored books on European law and Irish regulatory law.



Julie Inman Grant

eSafety Commissioner, Australia

Julie Inman Grant is Australia's eSafety Commissioner. In this role, Julie leads the world's first government regulatory agency committed to keeping its citizens safer online.

The Commissioner's career began at the US Congress in Washington, DC, before joining Microsoft, where Julie spent 17 years in various corporate affairs roles. At Twitter, she set up the company's policy and philanthropy programmes across Australia, New Zealand & Southeast Asia, and drove APAC-wide Government Relations for Adobe.

As Commissioner since January 2017, Julie has overseen significant increases in the eSafety office's budget, increased staffing levels, and launched innovative programmes such as the Safety by Design and Women in the Spotlight initiatives. She has established herself as a nimble and anticipatory regulator, establishing the innovative tech trends horizon-scanning program in 2020. Julie and her team are currently focused on compliance and enforcement of world-first systemic codes and standards, and implementing the social media age restriction bill through 2025.

Julie serves as a Senior Advisor to the Technology Policy Design Centre and is the current Chair of the Australian Digital Platforms Regulatory Forum (DP-REG). She served as co-founder and inaugural Chair of the Global Online Safety Regulators Network and is a long-serving Board Member of the WeProtect Global Alliance. She also serves on the World Economic Forum's Global Coalition for Digital Safety; represents Australia on the Global Partnership for Action on Gender-Based Harassment & Abuse, and serves on France's Laboratory for Women's Rights Online.

Manuela Martra

Deputy Head of Unit & Senior Expert - Accessibility, Multilingualism & Safer Internet, DG CONNECT, European Commission

Manuela Martra is Deputy Head of Unit & Senior Expert in the Accessibility, Multilingualism & Safer Internet Unit, in the Directorate for Data at the European Commission's Directorate General for Communications Networks, Content & Technology (DG CONNECT). She has worked for the EU institutions in Luxembourg for almost 25 years, most of them devoted to supporting a safer and better internet for children. Her current work includes coordination of the EU approach to age verification and the preparation of the EC cyberbullying action plan. She is very committed to ensuring, through a multi-stakeholder approach, that citizens, and particularly the most vulnerable, benefit fully from the digital transformation.



Liudas Mikalkevičius

Coordinator, Draugiškas Internetas, Lithuania (Lithuanian Safer Internet Centre)

Liudas Mikalkevičius coordinates the Lithuanian Safer Internet Centre (Draugiškas Internetas). He has spent the past three years strengthening national efforts through the integration of international best practices, including the BIK+ strategy and elements of the Digital Services Act (DSA) framework. His work places a strong emphasis on meaningful youth participation, including those from vulnerable backgrounds, ensuring that young people can identify the online challenges they face and co-create solutions. Under his coordination, Youth Panel activities and cross-border youth exchanges are central components of the Safer Internet Centre's approach.

Liudas has contributed to international expert group meetings and regularly participates in national parliamentary discussions related to children's well-being and suicide prevention. His academic background includes engineering degrees from universities in Lithuania and Switzerland, as well as studies in the United States. While committed to technological progress and innovation, he advocates for robust safeguards to ensure that digital environments remain safe and supportive for children and young people from all walks of life.



Davinia Marie Muscat

Team Leader, BeSmartOnline, Malta (Maltese Safer Internet Centre)

Davinia Marie Muscat is BeSmartOnline's Team Leader at Malta's Safer Internet Centre, under the Foundation for Social Welfare Services. In her leadership role, Davinia Marie actively delivers talks in schools, engages parents and children, and provides specialised training for professionals to prevent and address online risks. As a Helpline Officer, she offers vital support to those affected by cyberbullying, online abuse, and digital wellness challenges. Her work as a Hotline Analyst involves intervening in cases of child sexual abuse material, furthering the mission to combat online exploitation. Beyond her digital safety leadership, Davinia Marie is also committed to personal development, helping individuals heal, find balance, and rediscover their true selves



through a holistic and heart-centred approach. By integrating her expertise in internet safety and personal growth, Davinia Marie empowers others to cultivate a safer and more harmonious life both online and off.



Renate Nikolay

Deputy Director-General, DG CONNECT, European Commission

Renate Nikolay is Deputy Director-General in the European Commission's Directorate-General for Communication Networks, Content and Technology (DG CONNECT). In that role, she oversees the enforcement of the digital rulebook for platforms (Digital Services Act and Digital Markets Act), the policies on digital connectivity, data, media and audiovisual as well as international and interinstitutional relations.

Between 2014 and 2022, she was Head of Cabinet of Věra Jourová in her roles as Commissioner for Justice and Consumers and as Vice-President for Values and Transparency. Prior to that, Renate Nikolay was Head of Unit in DG JUST and served as a member of the Cabinets of Cathy Ashton and Peter Mandelson.

Renate Nikolay started her career in the European Commission in 2003 in DG Trade after having worked as a diplomat at the German Permanent Representation to the EU in Brussels and at the Federal Economics Ministry in Berlin.

Renate Nikolay has a law degree from the Free University of Berlin (Erstes und Zweites Staatsexamen) and a Master of Laws as a Fulbright Scholar from Washington, DC. She also participated in an Erasmus exchange with Grenoble/France.



Elisabeth Secker

Managing Director, USK - German Entertainment Software Self-Regulation Body, Germany

Since January 2018, Elisabeth Secker has been Managing Director of USK, the German Entertainment Software Self-Regulation Body. In this role, she and her team coordinate the age-rating process for digital games in line with German youth protection regulations and work closely with partners across the games industry, as well as national youth protection authorities. Furthermore, Elisabeth and her team are dedicated to helping families build media literacy around games through a variety of initiatives. She also serves on the Board of the International Age Rating Coalition (IARC), a system which provides a globally streamlined age classification process for digital games and mobile apps.

Before joining USK, Elisabeth was Deputy Head of the Department for the Protection of Minors at die medienanstalten, the umbrella organisation of the 14 state media authorities in Berlin. In addition, she serves on the Advisory Board of the Digital Games Culture Foundation and the Safer Advisory Board of an international gaming platform.





Tomasz Smaczny

Parenting Educator and Team Coach

Tomasz Smaczny is a Parenting Educator and Team Coach, promoting leadership inspired by mindful parenting. He is the author of "Pozwól dziecku być" (Let the child be) – the first Polish parenting guide inspired by the RIE approach. He holds diplomas from six universities; his multidisciplinary education (psychological, sociological, intercultural, and economic) allows him to view parenting from various perspectives. He co-created one of the largest Polish parenting groups on Facebook, Lepszy Tata – ojcowskie inspiracje (Better Dad), and acts as an ambassador for the Share the Care Foundation. He is a father to his 9-year-old daughter, Tosia.



Yvo Volman

Director of the Data Directorate, DG CONNECT, European Commission

Yvo Volman is Director of the Data Directorate in the Directorate General for Communication Networks, Content and Technology of the European Commission. Yvo studied at the Universities of Amsterdam and Strasbourg and holds a PhD in European law awarded by the European University Institute in Florence. He worked for the Dutch Ministry of Economic Affairs in the areas of industrial and technology policy, before joining the European Commission in 1998. In the Commission, he deals with legislative and strategic issues as well as funding programmes related to the information market, digitisation and data.



Marina Wetzer-Karlsson

Cigarettes, alcohol and drugs
